The Affiant states that, on the morning of 9/18/2024, the Defendant was found to have a shell casing on the driver's floorboard of the vehicle he was driving. Furthermore, in the passenger seat of this vehicle was a deceased female, who had a gunshot wound to her throat. When the Defendant was located, he had a large amount of apparent blood on his person. According to the Defendant's criminal history, he is prohibited from possessing firearms or ammunition as he has been convicted of armed robbery while armed robbery with a deadly weapon. This offense did occur in Greenville County, South Carolina.
